

Cookie policy

Interio Integrity Services B.V. attaches great importance to your privacy and the protection of your personal data. In this cookie policy we explain how we use the personal data that we collect when using cookies, what we do with them, and how we process these data. We believe it is important to create and maintain an environment in which users of our online environment can be certain that there is no misuse of their information.

The Interio Integrity Services B.V. website uses cookies. These cookies are required to have the website work properly and to offer you an optimal experience as a user.

Areas of application

This website and associated cookies are managed by Interio Integrity Services B.V. with registered office Steenoven 2, Tricht (The Netherlands) with Crossroads Bank of Companies number 301.282.45. We act as data controller when we process the personal data from the users of our online environment using cookies.

We act in compliance with the applicable regulations relating to data protection such as General Data Protection Regulation no. 2016/679 (GDPR) and national laws relating to data protection. These regulations concern the protection of your personal data and give you rights with respect to the personal data.

The purpose of this policy is to explain which personal data we collect using cookies and how we use your data after you have visited our website using a desktop computer, tablet, smartphone or other medium on which the cookies are installed.

What are cookies? Cookies are small text files that contain and save small pieces of information such as your language preference when you visit our website. These cookies are saved on your computer, tablet or smartphone when you visit our website. Cookies can contain person-identifying data, but this is not always the case.

When you visit the website again later, this cookie will send information to the website so the website recognizes your browser and can for example remember your language preference. Some cookies also allow use of certain functions on a website, or record how visitors to the web site use our website so we can use this information to optimize the website.

Cookies often have an expiry date so they are automatically deleted after a certain time. Some cookies such as session cookies are immediately deleted after the browser is closed, while other cookies stay on your appliance for a longer time.

We are required by law to ask for your permission to use some of these cookies. On this page you can read everything about which cookies we use and how we use them, and you can change your cookie preferences as you wish.

Types of cookies

Cookies have a number of functions including remembering your preferences, recording visitor behaviour (web analytics) and for example to show relevant advertisements on other websites. We use our own first-party cookies and cookies from third parties or third-party cookies. Although we do not need permission to install cookies that are strictly required for the working of the website, a summary of all types of cookies with explanation is provided below.

Necessary cookies and preference cookies

These cookies are strictly required for the technical working of the website and ensure that a website can remember information that affects the behaviour and the form of the website, such as your preferred language or the region where you live.

We do not require your permission for these cookies, also not if they originate from third parties that we use. These cookies have no impact on your privacy and are used anonymously.

Statistical cookies We use these cookies to analyse use of our websites so we can improve its functionality, quality and effectiveness. We need this knowledge to be able to adapt and improve our website. We then use the information to for example make sure that you can find certain parts more quickly. The statistics we collect cannot be traced back to individual persons. The visitor's IP address is made anonymous.

Marketing cookies With these cookies we record how you use our website and we try to help you choose a product that matches you best based on your website behaviour. We can then show products or services, personal recommendations and advertisements that may interest you. We may only install this type of cookie with your permission because these cookies are not strictly required for our website.
